BOOKING TERMS AND CONDITIONS

1. The Contract

A contract shall be deemed to have been made between Temple Roberts Ltd and the booker when the booker has completed and signed the booking form and returned it by e-mail or post to Temple Roberts Ltd and Temple Roberts Ltd has accepted the booking in writing to the booker.

2. Payment

100% payment will be due by return on all bookings of £5,000 inc VAT or less. If the value is above this amount and more than 3 months prior to the concert date, a deposit invoice of 50% of the overall cost of the booking will be charged and must be paid within 14 days of the issue of the invoice. The balance invoice will be due for payment 3 calendar months (4th March 2012) before the date of the event.

3. Extras

All accounts for any extra services and goods provided at the event which are not covered by an inclusive package cost are due for payment within 7 days of receipt of invoice.

4. Remittance advice

On receipt of payment a remittance advice will be emailed or sent by hard copy to the booker as confirmation of the booking.

5. Cancellations

Cancellations by the booker after confirmation will not be accepted, other than those at the sole discretion of Temple Roberts Ltd.

Should the event be cancelled by the Event Promoter or Temple Roberts Ltd up to day before the event, the booker will be entitled to a 100% refund, less an administration charge. Excluding National Mourning and other exceptions (please contact us for the exclusions), where there will be no refund. If the event day and / or hospitality starts and then is cancelled, the booker will receive no refund. If the event is postponed, the booking will stand for the revised date and the booker will receive no refund.

6. Liability

Temple Roberts Ltd will not be responsible for loss, damage or injury to any person at the event, howsoever caused. Temple Roberts Ltd shall not be responsible for possessions brought to the Event by the client or its guest.

7. Availability

All packages offered are subject to availability. Your booking will be confirmed in writing by Temple Roberts.

8. Complaints

Any complaints must be registered in writing with Temple Roberts Ltd within 28 days of the last day of the event. Temple Roberts Ltd can not be liable for any complaints received after that period.

9. Ticket & Hospitality documents

Tickets (where applicable) and other admission documents will be dispatched approximately 2 weeks before the event providing full payment has been received.
